

RECIPROCAL MEMBERS' AGREEMENT


**BETWEEN DUNTRYLEAGUE GOLF CLUB
and Penrith Golf & Recreation Club Ltd.
(Hereinafter referred to as "The Reciprocal Club")
to date from the 13th August 2009.**

- @ Subject to such qualifications, restrictions and limitations contained herein, the following reciprocal rights for the specified categories of members are hereby arranged and agreed between Duntryleague and the Reciprocal Club.
- @ Full Playing Members of the Reciprocal Club shall have full playing rights at Duntryleague upon payment of competition fees as defined on the day, and Duntryleague members are expected to be extended the same rights at the Reciprocal Club.
- @ Members of the Reciprocal Club shall pay a nominal \$10 Green Fee (or as determined by the Board of Directors during the period of this agreement) for any social round.
- @ "full playing golf rights" are defined as follows:-
 - (a) Play golf at any time when the Course is open for play but subject to such restrictions as may be decided by The Match Committee in relation to the use of the course during social or closed competition play; In this regard, Reciprocal members should check current restrictions prior to arrival. Such restrictions also cover conditions regarding the use of motorised buggies, private or Club owned.
 - (b) Play in a Club competition and win a trophy, subject to payment of the prescribed competition entry fee; but not to win a Club Championship, Monthly Medal or donated trophies.
 - (c) To have access to all available facilities and amenities of the Club subject to such conditions relating to the use thereof as may exist from time to time.
- @ Each of the undersigned Clubs shall extend to visiting Members of the other Club rights and privileges given to its own Members in the equivalent category of membership which is closest to the rights and privileges to which the visiting Member is entitled at their own Club.
- @ Members and Lady Golfers shall be required to show proof of Membership and current playing handicap, on request.
- @ No joining rights are granted to members of either Club under this agreement and nothing in these rights shall be construed as giving any member preference in joining either Club except in accordance with the terms and conditions of entry and membership as prescribed in the Constitution, By-Laws and Rules of each Club and payment of fees determined by each Club.
- @ Members of either Club are admitted to the other Club, under the general terms and conditions prescribed in the Constitution, By-Laws and Rules or other authoritative instructions of the other Club.
- @ This agreement shall remain in force until such time as either club upon written notice terminates it.

We the undersigned, being persons properly authorised to commit Duntryleague and the Reciprocal Club to reciprocal arrangements, do hereby declare that this agreement shall come in force as from the date stated above and shall remain in force until amended as may be mutually agreed between Clubs or cancelled by either Club on giving six months notice in writing to the other Club.
