



RECIPROCAL RIGHTS AGREEMENT

- 1) The following reciprocal rights for the playing members are hereby agreed between Forster Tuncurry Golf Club and the Reciprocal Club.
- 2) Green fees charged to your members shall be at the same rate as local members and it would be expected that the same would happen when our members visit your Club.
- 3) **Playing Rights are**
 - a. Offered only to members in the Full Playing category of the Reciprocal Club.
 - b. Limited to playing six (6) rounds of golf (social or competition) per calendar year and would be subject to any restrictions made by the Match Committee in relation to the use of the course at any time.
 - c. Visitors may win trophies in competitions excluding Monthly Medals and donated trophies.
 - d. Cannot compete in any Club Championships but can play in the event of the day.
 - e. Have full access to facilities and amenities of the Club subject to conditions from time to time.
- 4) Proof of Full Playing Membership, either displayed on a membership card or a letter from the Reciprocal Club will be required, otherwise full visitor rates will apply.
- 5) No joining rights or preference to joining either Club will be granted under this agreement except in accordance with the terms and conditions of the constitution, by-laws and rules of other authoritative instructions of the other Club.
- 6) Members of either Club will be admitted to the other Club under the terms and conditions of the constitution, by-laws and rules of the other Club. Members must sign in as temporary members to access the licensed premises.
- 7) Members playing in competition must report to the starter at least 15 minutes prior to their playing time.
- 8) Privately owned motorised carts or bikes can only be used with prior approval from the Club and may be subject to a small charge.
- 9) Reciprocal privileges shall only apply to members who ordinarily reside outside a fifty (50) kilometre radius from the host Club. Proof of residential address may be required to be shown, otherwise full visitor rates will apply.

We, the undersigned, being persons authorised by the Forster Tuncurry Golf Club Limited and the Reciprocal Club, hereby declare that this agreement shall be effective. Any amendments may be mutually agreed between the Clubs or cancelled by either Club by giving one (1) months notice in writing to the other Club.
